GUAM PUBLIC HEALTH LABORATORY GUIDELINES SPECIMEN REQUIREMENTS FOR FOODBORNE ILLNESS COMPLAINT INVESTIGATION

| Case Definition | A patient under investigation (PUI) for Foodborne illness must be vetted by the Department of Public Health and Social Services (DPHSS), and can be defined as a person with the following characteristics: Clinical Criteria: Diarrhea, abdominal cramps/pain, vomiting, and/or fever of greater than 38.6°C or 101.5°F and additional symptoms such as headache, muscle aches, sweat, weight loss, chills, exhaustion, and/or arthralgia; AND/OR NOTE: Sometimes, people have little or no fever, followed by other symptoms and clinical criteria. Others may experience: Illness of variable severity; common symptoms of diplopia, blurred vision, bulbar weakness, and/or paralysis; Weakness, splenomegaly, meningitis, anorexia, sometimes constipation and/or neonatal sepsis. | Specimen Submission Guidelines | Call the DPHSS at 671-689-3942 before collecting and sending specimens for suspected Foodborne illness investigation. <u>NO</u> SPECIMEN WILL BE ACCEPTED AT GPHL WITHOUT PRIOR CONSULTATION WITH THE DPHSS TERRITORIAL EPIDEMIOLOGIST. Collection kit and containers for specimens will be provided by GPHL and/or reference laboratory and must be labeled with patient's name or Identification (ID) number, specimen ID number and date of collection. Specimens for transport to the GPHL must be placed in a sealed biohazard transport bag and placed in a sealed, decontaminated primary sterile container. Specimens collected should be packaged and transported within the facility without attempting to open collection specimen container. Wrap the specimen with absorbent material and place in a sealable specimen biohazard transport bag and into a secondary watertight, leak-proof secondary receptacle. Fill out COMPLETELY the Guam Public Health Laboratory (GPHL) and/or CDC Submission Form, as needed. Once specimens ready for transport, call the GPHL 671-300-9082 or 671-300-9085 to inform staff of the specimen delivery. Specimens will be sent to reference laboratory for testing. |

This includes wearing personal protective equipment (PPE) and adhering to engineered safeguards, for all specimens regardless of whether they are identified as infectious. |
| Specimens | For specimen collection, recommend to: Use full face shield or goggles, mask to cover all of nose and mouth, gloves, fluid resistant or impermeable gowns. Additional PPE may be required in certain situations. Transport specimens to GPHL. Specimens must be placed in a sealed, decontaminated primary container, which is then placed in a sealed biohazard transport bag. All disposable wastes (PPE) used for collection and processing should be autoclaved. |

| Specimen Transport Guidelines | Transport specimens at room temperature within 24 hours; with cold refrigerant packs (2-8° C) within 48-72 hours.Deliver specimens to the GPHL no later than 4 PM, Mondays-Fridays. |
| Rejection Criteria | Specimens sent to the GPHL without prior consultation and notice. Specimen quantity is insufficient to perform the test; Specimen collected in glass tubes. Specimen not packed as described in Specimen Submission guidelines Specimen is not received at 2-8°C/ packed on cold packs; Unlabeled specimens, incomplete label on specimen (Refer to Specimen Submission Guidelines). Illegible/ incomplete Submission form (e.g., no date of onset, clinical description, etc.) Specimen label does not match the Submission form. |
| Result Notification | Laboratory reports will be forwarded to the Submitting Facility, and the BCDC Administrator via FAX. Any other request for copies of laboratory reports, apart from that stipulated above will not be accepted. |
